Good evening everybody and welcome to the regular council meeting for August 14 2019, following the Pledge of Allegiance. The next item is approval of the Agenda Council I have no changes tonight so I'll entertain a motion on that one.

Next is discussion items. First up tonight as matter from Moriarty Edgewood school district we have Theresa Salazar Superintendent here, welcome Teresa. Thank you Mary Thank you council members for inviting tonight I appreciate it. We have about, well, we have one full day under our belt we had jumpstart on Monday, and then first through second, and some of the bigger kids came yesterday and preschool came today so everybody's there today. So it was our first day. So it's been very busy the last several weeks, and some exciting stuff going on. We found out yesterday that two of our minority high school students will be participating in the New Mexico Human Rights Project mock International Court, which there's eight students from New Mexico, which are going to be representing all of the United States. In Poland, their other teams will be from Poland, Germany and Israel. And those two students are Jessica army whoa and Rebecca page, so they'll be going in November. I hope it's not too cold and snowy November I don't know what the weather is but it's kind of like but they're they're excited so they're very they'll be representing New Mexico well.

We are excited with our 78 preschoolers three and four year olds that we've had. And the last two days. We added a four year old program so if anyone knows four year olds out there that still would like to come to preschool we have a few spots open so please bring them our way.

We are having a ribbon cutting for the Moriarity high school can instruction that will be semi completed almost, we have moved in and we are having class. On August 22 so that's next Thursday night at 530 and we would love for all of you to attend and be a part of that ribbon cutting because it is our communities that made that possible with bond election so it's really neat. There's some 530 at 530 yes right there in front of already high school you won't even recognize it. But it says more than I ever recognized nothing in there is yours. But it says really big in the front sir Moriarity high school so you'll know which we did you're at the right place.

And we've been working on several things over the last year, and one of the things is bringing wind energy technology classes through Mesa lands Community College to the valley and Moriarty High School, and that's both with students dual credit as well as adult learners, it we're getting closer and closer we work did a presentation with the Torrance county commission this morning, and looking for 75,000 to \$100,000 to support Mesa lands with that and working with that we're excited about the opportunities for our students at Moriarity High School, which includes the Moriarty and Edgewood students. This is also going to be for adult learners there's going to be two separate paths IE one during the school day for students and then one after hours and Saturdays for adult learners. It's going to coincide the one for the adult learners with the opening of trying to think it slipped my mind, it's not pace.

They're going to, so a year it's going to probably be next fall or spring before we start those classes, and those are going to be really focusing on our 18 plus learners. And they are going to be sponsoring 10 students to go through there and it'll, they'll pay for their whole program, and then be being employed after that so that's looking at \$22 an hour starting jobs. So that's very exciting for our area. We're excited about that. One of the other things that we've been working on and I want to thank Councilmember Linda Holly for that is working with CNN, and with for first choice. She has connected us and got first choice involved we had a great meeting with CNN. A couple of weeks ago and bringing some classes to the Edgewood area and doing the medical assistance and kind of a starting Running Start of what kind of classes can be offered what opportunities are there in the medical field is it only nurses and doctors, well it's obviously it's not so looking at that and kind of hooking those high school age students so that we can move forward and continue through cnn so they could be halfway through a program have certificates, but go ahead and get their associates and go on and get their bachelor's and do the majority of it here, through that first choice has job shadowing there. Do internship there are part of the district would be providing students during the day of course for an offering classes at the high school, but then after hours weekends for students and adult learners doing it at the Edgewood Middle School campus and having the classes.

Would you like to add anything Council. I guess what I would say is our job as a town is to get the word out when we've got more details, we'll share it with all of you but the key thing is to get enough enrollees you know for seeing them to continue offering courses out here so we've got a good partnership going already so, and we're actually going to both of these starting in January so spring of 2020 is when we're looking for these courses so we're really pushing to get the advertisement get the dates get the times, all that information out soon, so that I am different meetings different opportunities that we have to get that out because that's kind of where we've run into problems in the past is getting the communication and getting it advertised to people so that they understand real what they need to do to register. I know that we were working with CNN on a project last, maybe last year in the fall, and the people didn't they didn't advertise it that they had to go online so there's people standing at the doors, and it's like the class would have made if you know there would have been someone there to do that so it's just that communication piece so we really need to work on that and need everyone's support on that.

Let's see, security doors, I was just talking to the chief, we have new security doors dozens and all the schools and new Raptor as the system that you have to go in, put your government ID, including your driver's license to, it goes out to the national database for sex crimes on and custody issues. And so those are things that we're going that we've been adding using bond money that our community has very generously voted in approval of so those things have been implemented for the school year. The chief is going to be going and looking at those systems because we're going, you know, it's, it's good to keep the bad guys out but we've got to make sure we get the good guys can get it. So those are some of the things that we're going to be working through but you know it's it's kind of some growing pains and you may hear some growing out there that it's like I can't get into the school it's like well you can but you have to go through a process and it takes a little bit longer and I'm very disappointed that that's where we're at in society but it is and so we want to make sure that our kids feel safe and our parents feel safe with bringing their kids to school. So, the only other thing that we have. The only other thing we have going on. There's many things going on but that I wanted to share is

Every year, we'll get it down. We do have bus drivers for every bus so that's a very, that's a plus we did not have that all year last year. So, we have all our buses filled so that's a plus one question would be, who handles that electric sign out here, the messages on is that still Superintendent over here. Todd Libby auto and principal he's actually moved to Central Office he's the new director of personnel but it's he's still in charge of it so if you have anything you need up there you can just call central office and we'll get you hooked up with Mr baby I know for enough so by yeah he's got the key to the back door to go into the, you know, there's got to be an easier way but that that's what works for now.

I do have questions. I'm Superintendent glad to see you. I was curious how hiring is going this year with the changes in salary levels, you know we have done really well, and we've gotten quite a few really hard to staff positions. You know, for the special programs for special education, some high school counselor. We've been very blessed to get some good candidates for that we do still we had a resignation. Two weeks before school started from one of the high school math teachers who decided to go back and work on his doctorate says like you didn't know that in May, but okay he's young, so he's a millennial so we'll give him a pass on that. So that position is open. We're looking for a math teacher there we do have, we're doing edge annuity and we do have a licensed teacher but not licensed in math, in that class but you know we have a live teacher on the other end that's that's certified in that. So, that is the one at the high school we have three special education positions. One gifted in a preschool. So, you know, it sounds like a lot but in comparison to other districts our size and locations and we're not APS that has 175 openings so.

So, when it's high quality I was very pleased with the new staff orientation and I think it's a quality group this year so we're excited about that. What about enrollment. So enrollment we know we're up 100 from yesterday, you're just at the high school, you know, this week, it's, I think it's optional, you know it's like it's a suggestion that you got this week. So we're at 2300, we expect to be closer to 24 by next week so we'll be having more solid numbers next week. Okay. And then we've talked about youth programming. And I know one of the great ideas Carla has is the GD program so I just wasn't sure if you guys had connected on that I talked to Elizabeth and just wanted to make sure that we had something moving along. Yes, Carla and I've talked to a couple of times we are trying to figure out how to get the information without giving student information to out to you know get people connected to it is find out, identify who those students are that would qualify for that program. And so I think that we kind of have an idea of how we want to do that. And so we are moving along so it'll I'm thinking it's going to be a fall thing but Mr granary from the high school he was our guidance counselor and now he's an assistant principal is who will be working with her directly on that. So, great, thank you guys very much for doing that drug prevention and other thing I talked with Elizabeth about, I think that the best way I can think of personally to help is just donating to the, to the foundation I guess for anything that you guys need for that sounds like there haven't been a lot of changes in the program yet but wasn't sure you know I think the thing that was very beneficial last year that we started about Christmas time and we're even stepping it up more is working with a team court and you know vaping, I'm sure all of you have seen on the news 60 minutes. It's an epidemic. I mean, that would never have smoked

a cigarette would have never, you know, drank beer there vaping. They think that it won't hurt them it's you know the education part of it so those are things that we're working on, and really making a believer the first time. And, you know, if you're caught there's a whole scenario that you have to go through parents have to go with the student to Team court and go through that process and it's basically an education of it at the middle school level there is suspension from that from school because we think we can get them with the suspension and you know get parents and kind of the shock treatment, truly by the high school level, they're addicted, so it's more of a cessation issue, then you know you don't want to kick them out of school, because they're addicted to something you know you need to keep them in school because they're going to be out smoking all day long. If you know if they're out of school so. So those are kind of some of the things and that that balance that you have to figure out. Mr. Adams in his staff are, you know, there's marijuana's prevalent, and it's kind of like the more that it's out there that, you know, parents have it maybe for medicinal than you know kids can get ahold of it, and it's out there so it's taking kids to hearing. When they, their first offense which before it had been like their second offense that taken them so it's really, you know, kind of jumping on top of that and making believers out of kids it's like we're not going to tolerate it. So, they, they are really focusing on and making sure that, you know, kids are safe and that's what's important, because again, you know, kids are thinking that doesn't apply to them or it's not that not nothing's going to happen to them, you know, there's schools that have to transport kids, daily and APS last year last semester, we had something that someone puts up a minute that was not what it really what they said it was and we had three kids take a hit off of one babe, we had to transport three kids just because of the reaction. So, you know, talk to your kids everyone that's like talk to your kids tell them to stay.

You know we didn't worry about that when I was a kid that wasn't an issue. So, but, and we're working very closely with our police departments and so I know that the chief and his staff go to, you know, the middle school if they need to. And then we have the majority police doing the same thing at the high school and middle school.

At First Choice is that where it will be at, you know, we actually visited with a CEO first choice he was at the meeting, and they're wanting to keep that large facility that large room for community activities and things that they're doing. So, those classes will be held at Edgewood Middle School. But if it's the job shadowing, and that they need to be on you know do an internship that will be at first choice.

And that way we can dedicate a class if there's equipment if there's, you know beds if there's different things that they need, they can just leave them there and then the first choices and having to work around those, is it just a medical program right now. That's what we're starting with its we filled that with a partnership with first choice, CNM can see a pipeline and can see a purpose for that. And so we think that once we kind of get them hooked, then we can you know move from there. One of the things that will also be doing is doing actually place or we'll provide the product. The proctors for that the computers and work with them on that so that's what we currently do without your hard job credit. So all Dual Credit students so high school students that are registered that's paid for by dual credit, so that will be tuition free, as well as textbooks, adult learners will have to pay for that but it's going to be at the end district rate, and what did I tell you that was \$65, an hour and 100 and whatever three times 65 is, I could have told you that this morning but just looking at that for a client in Clovis actually today about the statue, and that the colleges and universities cover the tuition. But then the fees, the responsibility for the fees is on the student, not the district, necessarily, but that, you know, a foundation or, you know, other entities could provide a scholarship or could donate money to help those students. So, and you know one of the other things that Linda and I talked a little bit about the other day is looking at our Workforce Solutions out in this area because I really think that they can help support those programs and our kids and our adult learners, because I know that they have a program where a little even pay for mileage to drive to campus, and a you know a portion of tuition and different things so for our adult learners to help support that so that's one of the things on my list to be

looking at and being able to provide you know as we advertised you know and if you need tuition support or you need, you know, this is your contact is because I think that's what's going to make it successful.

Next item is an update from a statue based water planning committee Dan McGregor, Mr Mayor Council. I'm Dan McGregor I'm the secretary treasurer for the Stasi based water Planning Committee. I am here this evening on behalf the committee normally Rick Thompson would be provided potential conflicts of interest is straight to take this assignment for this evening so thank you for your time. I appreciate it. First I do want to thank the, the town for their support of the stanzi Bayswater planning committee in past two years, you've provided support in the amount of \$2,000 a year for us. That does help us sustain the programs that we do. I have a current letter in with finance department for payment for 2020 presuming that it was in your budget. We failed to communicate well last year, and making that request believe that some process from Mr Torres is nodding his head affirmatively. So I've accomplished my mission tonight for the base and.

And then also, to let you know that will be coming in due time. As part of the budget process making the request again for next year. So, just put things in perspective, starting based and planning committee originally back in 96 was formulated by a Tri County agreement between Santa Fe torrents and Burleigh County, and we've been the Regional Water planning MD working with the ISC throughout those years, last update our plan was in 2016, under the IOC, and we continue to collaborate with the IOC as those requests come in. So, what the largest project that we take on is a basin wide water level monitoring program. This is done in extra to what the OSC does on a, on a five year basis. Plus, we have a little better reach out into the community and describe a wells. And I think that's because we are local and there's a certain amount of trust that's involved in getting into those landowner properties, making those arrangements. One of the portions of that program is we do quarterly water level monitoring rounds. Those run about 30 \$500 a monitoring run. And then we also have a series of transducers, which are water level recording devices that are in about 13 wells. Unfortunately over the last few years just due to age and normal wear and tear a large number of those transducers have gone down we're down to I think about eight transducers now. And so, where a lot of the funding from this year will go will be paying for those replacement transducers that data then is used by a variety of sources, the Stasi basin study that was done by bureau of geology by Stacy Timmons incorporated some of that data into their studies.

I was able to use it in from Burleigh counties perspective and working with Campbell ranch case, and other entities intranasal some of the other water suppliers in the base and also use that data and supply data to us as well. So, in terms of funding we're funding generally comes from is we typically have a reimburse double mo you with Santa Fe and the amount of 10,000 per year. We're still trying to get that in place for this next

year. Burnley of county provides 2750, a year. And then Moriarity EyeOnEdgewood are providing 2000 a year apiece. And then it stops your base and pays 500. So to put things in perspective \$2,000 a year essentially covers one quarterly monitoring run for us it's a little bit shy about. But if we don't receive those funding them we have to start pulling back on the contractors.

And there's a little bit of loss of efficiency when you start dropping off a quarterly runs transducers die out over that six month period that sort of deal. So we are kind of a minimal functional sort of level with requests we have. We feel like we are providing a good service. One of the other increased costs, we had was changing websites, you'll still find us under, or excuse me, the host servers that costs, went to 375 a year from 150. So just like any other entity, we do have small increasing costs from time to time. Currently we're able to manage that.

And the reports that we get with water level, we post to those sites as well as that's where we host our meeting minutes and agendas, to meet our open meeting requirements. So with that I happy to Stanford any questions again, thank you for your continued support is very much appreciated. And also thank you for lending us. Councillor Abraham to serve on that committee as well. Thank you for the questions. I do have a quick question is, how is your entity organized, are you a nonprofit, are you under a GPA of all these entities or. So the way that that organization is formulated is under an mo you between the three counties. And in that Memorandum of Understanding the membership was laid out as part of that mo you.

And I'm going to get it wrong because I'm trying to work from memory and there's like 13 different members available so each of the counties has a, a development rep appointed by the county commission, a solo development rep and municipal prep. And then I believe Santa Fe and torrents also have an agricultural representative, that the respective councils appoint the soil water conservation districts also have appointed seats on that and then we have one at large member. I'm not sure that adds up to 13 I'm probably forgetting somebody, and then the duties and responsibilities for the entity are laid out as well. So we use drones county as fiscal agent they provide their income funding by allowing her staff to serve as our fiscal agent.

The as it being the base and, you know, they do continue to decline. The good news is that the rate of decline has decreased.

Some which indicates some stabilization, whether that is because of a decrease in farming and irrigating acreage or just because of the hydrology, essentially finally starting to come into balance I use that term very loosely with a pumping to where the, the recharge obviously hasn't increased any, but eventually things will reach to what we refer to technically as this steady state. And we're kind of getting into that curve to where that rate of decline is less name in this study and a bit more predictable.

We had a speaker here at one of our last meetings recently who indicated that people were reactivating the water rights out there in the area and starting to use them. So do you know have you guys looked at that how it's going to impact the levels, and I'm presuming that you're probably referring to attempt Perella, and I think he presented that information to some of the other councils in the base and. So, yes, those are being reactivated some of that is actually for him farming production requests associated without those are under existing water rights so to the best of my knowledge, there's not many any requests for new appropriations, their existing appropriations that they have legal access to, obviously any increase in pump is going to result in additional drawdown.

The upside and I've not looked at the numbers but just because of the nature of greenhouse farming and more specialty farming that net water use is probably less than alfalfa if it's done correctly. But I've not looked at the data to be able to stay down with me, certainly. Okay. Thank you.

You know, finding it out of our capital budget to put that in.
